## Introduction

In the vast and dynamic marine space, boundaries are not simply lines on a map: they represent complex processes of interaction between diverse political, social, economic and environmental forces. This basic introductory course on marine boundaries is designed to provide an initial and critical understanding of how these boundaries are conceptualised and studied in aquatic contexts. Its main objective is to promote interest among prospective and future students in coastal-maritime environments and their issues in transboundary spaces.

Over the course of four intensive days, participants will explore the theoretical foundations and practical applications related to marine boundaries. We will begin with a synthetic pre-













sentation of the conceptualisation of the marine boundary, with an emphasis on aquatic ontologies and their implications for the production of boundaries in marine spaces. This first day will also analyse the proposals for the development of seas and oceans of the so-called Blue Economy and the new political, social and environmental processes linked to this economic model. Finally, a critical view of the Blue Economy will be presented based on the principles of Blue Justice and its dimensions in the different associated governance orders.

The second day will be devoted to presenting different proposals for critical approaches to the study of marine boundaries. In a synthetic way, approaches beyond blue justice will be addressed, exploring decolonial, epistemic and intersectional justice. In addition, we will discuss political ecologies in marine environments, emphasising power, narratives, subjectivities and fishing identities. We will also approach the proposal to study water and marine boundaries from interdisciplinary historical perspectives. We will conclude this conceptual journey with the conceptions of posthumanism and non-human agencies in the configuration of marine boundaries.

The third and fourth days will be devoted to the presentation of case studies on marine borders and their problems in Latin American contexts, with the participation of various invited experts. These case studies will cover marine borders between Mexico and Guatemala, Colombia and Nicaragua, Peru, Chiapas, Costa Rica and Nicaragua, and between Chile and Peru. We will also address the production of internal borders from conceptions of *borders* of a different nature to the jurisdictional borders between nation-states. The diversity of issues that will be presented will provide students with a rich and multifaceted vision of marine borders in the region.

This course seeks to impart theoretical knowledge and also to foster a critical and constructive dialogue among participants, with the intention of promoting interest in future students in the topics covered. The activity is part of the training and dissemination tasks of the International Network for Environmental Justice (ENJUST), in its Mexico node. We invite those interested in learning about the academic, activist and artistic work of this network to approach the organisers of this course as active members of ENJUST.

# General objective

To provide a basic yet critical understanding of marine boundaries and their conceptual approaches from critical geography, marine social science and posthumanist political ecology, in order to encourage interest among future students in the study of coastal-maritime environments and their issues in transboundary spaces.

# **Specific objectives:**











- To explore the conceptualisations of marine boundaries and aquatic ontologies, as well as the production of boundaries in the seas and oceans, within the framework of the dynamics imposed by the Blue Economy.
- To understand the critical approaches to the study of marine boundaries based on the principles of Blue Justice.
- To present various case studies of marine borders in Latin American contexts in order to understand transboundary dynamics and their political, social and environmental implications in coastal-maritime environments.

#### Dr. Celia Ruiz de Oña Plaza, CIMSUR-UNAM

D. in Ecology and Sustainable Development; a degree in Ecological Sciences from the University of Edinburgh and in Information Sciences, specialising in International Relations, from the Faculty of Social Sciences of the University of the Basque Country. She addresses the intersection between Political Ecology and Border Studies, through the prism of Blue Justice. Her work contributes to the understanding of new forms of coastal appropriation based on neoliberal conservation strategies and the commodification of nature. She seeks to develop a posthumanist approach to socio-environmental conflict in the context of the climate and civilisational crisis. Member of the ENJUST Network.

### Dr. Víctor Velázquez Durán, ECOSUR-Tapachula

Graduate in Human Geography from UAM Iztapalapa. Master and PhD in Geography from UNAM. He is a postdoctoral fellow at the Sustainable Management Area of Basin and Coastal Zones of ECOSUR-Tapachula. His interests are focused on understanding the environmental challenges faced by coastal populations in the face of catastrophic climate change scenarios, as well as their diverse strategies and social innovations to make sustainable use of the natural resources of their territories. She is currently researching the intertwining













of multiple marine-oceanic boundaries in the Southern Border of Mexico, where different actors are competing for the control of natural resources and generating dynamic processes of territorialisation. Member of the ENJUST Network.
